Is Blinken plain incompetent, or is he deliberately screwing things up? Ties to Soros may be revealing

It seems like everything comes back to George Soros. Since Biden was inaugurated in 2021, our foreign policy has been one abject disaster after another, now completely exposed by the debacle taking place in Ukraine.

While we saw four years of “mean tweets,” we also did not see the type of turmoil currently taking place across the globe. And a lot of that turmoil can be traced back to Secretary of State Antony Blinken.

Let’s examine Blinken’s record in about 14 months. Afghanistan? A total disaster. Thirteen dead U.S. service members, \$84 billion worth of military equipment left behind for the Taliban and the US with our collective tails between our legs was the biggest military and foreign policy blunder in American history.

The worst part is it was completely unnecessary.

Now, Blinken is involved with trying to work out a nuclear deal with Iran, an ill-advised exercise which will put our greatest Middle East ally, Israel, completely under the gun, and which will likely lead to a number of

countries pursuing nuclear weapons in the Middle East. It will also pose an existential threat to the United States homeland.

Where Donald Trump had negotiated a number of deals under the “Abraham Accords” which saw Arab countries signing peace agreements with Israel, Blinken and his leader Joe Biden will likely see those same countries pursuing nuclear weapons to offset what Iran is surely planning to do once they get their nuclear deal.

To make matters worse, the Biden administration is using *Russia* to negotiate the deal with Iran. There is no sane reason for the United States to pursue this deal...none.

As [Gateway Pundit notes](#), it isn't just our foreign policy that is an abject disaster. Our southern border, or what is left of it is wide open, with hundreds of thousands of illegals crossing it per month.

Is this administration merely incompetent, or is it something far more egregious? Is all of this intentional? This brings us to George Soros and Antony Blinken's ties to the Hungarian-born socialist who is hell-bent on destroying our country.

According to former Senior Advisor for National Security and Foreign Policy under President Trump, Ric Grenell, much of this can be traced back to Soros.

In a May 2021 tweet, Blinken wrote:

“Former President of Albania Sali Berisha's corrupt acts undermined

democracy in Albania. I am publicly designating Berisha and his immediate family members as ineligible for entry into the United States. We remain #UnitedAgainstCorruption with our partners in Albania.”



In response in November 2021, Grenell [authored an article](#) published by the ACLJ. As Gateway Pundit notes, Berisha is widely recognized as a man who stood up against communism in that formerly communist country. There seemed to be no basis for Blinken writing this tweet. This is where the ties between Blinken and Soros and his Open Society come in. Grenell wrote:

Berisha has slammed the actions by the State Department as the work of radical left billionaire George Soros and his Open Society, an organization that claims to promote transparency and human rights in the Balkans. The ACLJ and our international affiliate, the [European Centre for Law and Justice \(ECLJ\)](#), have been [exposing](#) Soros's outsized, radical—and what some might call [corrupt](#)—influence on the world stage.

Berisha's claims regarding Secretary Blinken and Soros should not be dismissed so quickly. The U.S. Secretary of State's parents, Vera and Donald Blinken, have repeatedly donated to Open Society, even creating a permanent endowment at a European-based data archive that carries their name—The Vera and Donald Blinken Open Society Archives.

Congressman Lee Zeldin (NY-1), a member of the House Foreign Affairs Committee, recently confronted Secretary Blinken on his sudden sanctioning of Berisha. Secretary Blinken conveyed little confidence when asked for justification, stating "I don't have anything to share." While Blinken offered platitudes of follow-up for the Committee, no such information, or evidence, has been submitted. The circle-back saga continues.

At present, the only evidence we know of is Berisha's staunch opposition to Soros's political interference, which Mr. Berisha has decried as circumventing the rule of law and informal influence over the entire Balkans region. Mr. Berisha himself in 2017 called on major governments to investigate Soros's role in regional politics and went so far as to encourage others to declare Soros "non-grata."

Secretary Blinken now faces a new challenge to his authority in the form of international courts. Last week, the Correctional Tribunal of Paris announced that it would hear Berisha and his claim that Blinken has defamed his reputation by declaring him persona non-grata.


And Berisha has a point. These U.S. travel sanctions that Blinken has used against Berisha are typically a move reserved for some of the world's most

blatant, evidence-backed violations of international norms and human rights, including that of the likes of Russian oligarchs. Yet Berisha has been a friend to the U.S. and has even been hosted by both Presidents Bush.

Hmmm. Interesting. Many people have thought that Biden and his incompetent assortment of hacks and buffoons in his administration were deliberately trying to destroy our country and the American way of life.

WASHINGTON, DC- Remember the Julia Roberts thriller, *Sleeping With the Enemy*? Julia, meet Joe Biden.

The Daily Caller is [reporting](#) that Biden appears to be doing just that with Iran, as he continues to push for a nuclear deal with Iran despite reports that top leaders of that country have ordered the assassinations of at least two former Trump administration officials, former national security adviser John Bolton and former Secretary of State Mike Pompeo.

The outlet advises that Iranian Supreme Leader Ali Khameni considers Bolton and Pompeo as being responsible for the [assassination](#) of Quds Force Commander Qasem Soleimani, as first [reported](#) by the *Washington Examiner*.

It is reported that as a result of Soleimani's death, his successor Esmail Qaani has been ordered to avenge the dead general's death.

The *Examiner* reports that at least two Iranians belonging to the Islamic Revolutionary Guards' covert action Quds force have been plotting to assassinate Bolton, according to a Justice Department official with direct knowledge of the investigation.

Despite the fact that the Justice Department possesses that indictable evidence against the two men, the Biden administration is apparently attempting to derail such an indictment out of fear it could throw a monkey wrench into their plan of striking a nuclear deal with Iran, a deal

which would put the Iranian regime on a collision course to develop nuclear weapons.

According to the *Examiner*, that there is a possibility there are sealed indictments against the men, although they cautioned it is unlikely. However the DOJ source said the seriousness of the conspiracy and the evidence obtained “warranted public indictment without delay.”

The paper notes that a sealed indictment wouldn’t be necessary in such a case, since that is typically used to prevent a target from evading justice.

In this case, Quds Force is aware of an investigation by U.S. law enforcement and the fact they are a target of intelligence assets. Therefore it is unlikely their members would put themselves in a position to be arrested with or without a sealed indictment.

The *Examiner* is withholding some details of the plot against Bolton for national security reasons, however the “DOJ source described it in highly specific terms as supported by significant Revolutionary Guard reconnaissance activity and involved an effort to recruit an assassin on U.S. soil.”

The Daily Caller wrote that both Pompeo and Bolton have had their Secret Service protections extended by Congress over the threats, despite the fact both men are no longer in government service and have returned to private life.

Neighbors of Bolton have seen agents in marked vehicles parked outside of Bolton’s suburban Maryland home in late January, Forbes [reported](#).

Threats by Iran against current and former U.S. government officials is nothing new, with former Trump administration envoy Brian Hook being an example.

A 2022 Annual Threat Assessment from the Director of National Intelligence, [which was declassified](#), says Iran “has previously attempted to conduct lethal operations in the United States” and is expected to continue to “threaten U.S. persons directly and via proxy attack.”

In January, national security adviser Jake Sullivan [promised](#) “severe consequences” to Iran, in reference to “terror operations inside the U.S. and elsewhere around the world” against “those serving the U.S. now and those who formerly served.”

Yet, despite the threats against Pompeo, Bolton and others, the Biden administration, led by Chief Envoy Rob Malley, have offered the Iranian regime, including its president Ebrahim Raisi and Khameni, wide-ranging sanctions relief as part of a renegotiated nuclear agreement.

As part of negotiations, [restarted](#) by the Biden administration last June, the United States has [waived](#) some restrictions on Iran’s nuclear program, which the regime laughably claims is for “civilian” use only.

It is unknown why Biden is so anxious to lift sanctions on a country which has openly called for the destruction of not only our best ally in the Middle East, Israel, but the United States itself.

For his part, Pompeo remains undeterred in his support for the attack that took out Soleimani in 2020, [saying](#) he wouldn’t have changed a thing

about calling for the strike despite calls by Iran for revenge against him.

“Qasem Soleimani was actively engaged in plotting against America,” Pompeo tweeted on Jan. 3. “We took lawful military action to make sure that no Americans were killed. American leadership now has the responsibility to keep every American safe against the threat from Iran.”

American Military News [said](#) that in an interview with Fox News’ Sean Hannity, Pompeo said:

“I wouldn’t change a thing about what we recommended to the president. We were defending the United States of America, we were keeping the American people safe.”

Malley also inexplicably said the U.S. was [willing to drop](#) numerous U.S. terrorism-related charges against Iran in an effort to return to the 2015 Iran nuclear deal, which former President Trump withdrew from in 2018.

Among those included in those terrorism charges is the Islamic Revolutionary Guard Corps (IRGC), which has carried out numerous terrorist attacks, including against Americans.

The Daily Caller noted there are currently sanctions against 261 individual Iranians, as well as 714 Iranian business and government entities.

Any agreement forged with Iran is supposed to be submitted to Congress, which can pass a measure of disapproval blocking the U.S. from entering into it. However this isn’t a treaty, which can only pass if it passes the Senate by a two-thirds majority. In the case of a measure of disapproval,

Biden can veto it. The Senate would then require a filibuster proof vote to overcome a veto.

In 2015, all Republicans opposed a similar deal, with four Democrats, including Senate Majority leader Chuck Schumer voting along with 54 Republicans to oppose the deal. However those 58 votes were not enough to overcome the filibuster.

It is expected that many Democrats will not go along with a new Iran deal, especially in a year when Democrats are expected to get their collective asses handed to them in the November midterms. Last week, twelve House Democrats told Biden that it will “hard [for them] to envision supporting an agreement along the lines being publicly discussed.”

“We are highly concerned about reports indicating the potential lifting of the Foreign Terrorist Organization (FTO) designation of the Islamic Revolutionary Guard Corps (IRGC) and of the sanctions placed on members of the office of the Supreme Leader,” they wrote in a [letter](#), first obtained by Jewish Insider, to Biden and Secretary of State Antony Blinken.

Biden continues to press for this despite threats against American citizens, in particular former government officials by a foreign power, constitutes an act of war.

When asked about whether or not the suspects would be charged, a Department of Justice spokesman said:


“As a matter of Department policy, we do not confirm or deny non-

public law enforcement activity. In every case, the Department’s decision whether to charge would be made based on the facts and law in accordance with the principles of federal prosecution.”

The *Examiner* said it reached out to the National Security Council for comment, which was refused. Meanwhile the Secret Service said that “in order to maintain operational security, the Secret Service does not discuss our protectees or the means and methods used to conduct our protective operations.”
